# UNDERSTANDING THE PROTECTION OF PERSONAL INFORMATION ACT (POPIA)

#### PROGRAMME OVERVIEW

The Protection of Personal Information Act (POPIA) is a new data protection law in South Africa that aims to protect the privacy of individuals by regulating the processing of their personal information. This course is designed to provide a comprehensive understanding of the POPIA, its principles, and its implications for businesses and individuals who process personal information.

# THE COURSE WILL COVER THE FOLLOWING TOPICS:

**Introduction to POPIA:** This module covers the background and context of the POPIA, including its purpose and objectives, and the legal framework surrounding it.

**POPIA Principles:** This module covers the eight principles of POPIA, including the purpose for which personal information is collected, the type of personal information that can be collected, and the manner in which personal information should be processed, among others.

#### TARGET AUDIENCE

This course is designed for individuals who process personal information in their work, including business owners, HR professionals, IT professionals, marketers, and compliance officers.

#### DURATION

The course is expected to take approximately 16 hours to complete. The course will be run over 2 days.
